## PUBLIC PATH DIVERSION ORDER UNDER THE TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257

# THE STAFFORDSHIRE MOORLANDS DISTRICT COUNCIL PUBLIC FOOTPATH (NUMBER 44) (PARISH OF CHECKLEY) ORDER 2025

This Order is made by **STAFFORDSHIRE MOORLANDS DISTRICT COUNCIL** under Section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to divert the footpath to which this Order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely a housing development of 67 dwellings at land off Cheadle Road, Upper Tean under planning reference SMD/2022/0249 (the Approved Planning Permission).

#### BY THIS ORDER:

- 1. The footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be diverted as provided below.
- 2. There shall be created to the reasonable satisfaction of the Staffordshire Moorlands District Council an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
- 3. The diversion of the footpath shall have effect on the date on which Staffordshire Moorlands District Council certify that the terms of Article 2 above have been complied with.
- 4. The following works shall be carried out in relation to the highway more particularly described in Part 2 of the Schedule in summary only the alternative footpath shall have a width of 2.0 metres; shall have a hard surface part in hoggin and part in tarmac; and shall include a short flight of 11 steps in brick and paving slabs in accordance with the steps design plan attached to this Order.
- 5. Where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

#### SCHEDULE

#### PART 1

### **Description of Site of Existing Path or Way**

A section of footpath approximately 129 metres in length running from Breach Lane at point A (Grid reference 400610 340492) as shown on the attached map and running in a generally south-easterly direction to point B (Grid reference 400703 340405) on Cheadle Road as shown on the attached map

#### PART 2

## **Description of Site of Alternative Highway**

The new section of footpath to be created as shown on the attached map shall run from point A (Grid reference 400610 340492) in a southerly direction for approximately 38 metres to point C (Grid reference 400610 34045) from where it will then curve gradually through 90 degrees over a distance of some 35 metres to a generally easterly direction for a further 70 metres approximately to point D (Grid reference 400702 340423).

Approximately 2.6m before the new section of footpath meets point D there shall be constructed in cemented brick and paving slabs and in accordance with the steps design plan attached to this Order a flight of 11 steps 2.0m in width to climb through approximately 1.6m over a distance of approximately 2.6m. Point D is located on Cheadle Road approximately 18 metres north of point B.

The new section of footpath shall be 2.0m in width and shall be surfaced with hoggin for approximately 75 metres from Point A (Grid reference 400610 340492) to Point E (Grid reference 400636, 340432) where it meets a pavement at the end of the new proposed hammerhead. From Point E (Grid reference 400636, 340432), approximately 26 metres in length shall be constructed of tarmac to Point F (Grid reference 400663, 340432) when the path returns to hoggin surfacing for approximately 39 metres until it meets the flight of steps 2.6 metres before Point D (Grid reference 400702 340423), in accordance with the Approved Planning Permission.






# Town and Country Planning Act 1990, Section 257. PROPOSED Diversion of Public Footpath No. 44 Checkley Parish.








ELEVATION - SCALE 1:20
