Your Comments

Policy CF2 identifies several existing community facilities in the neighbourhood area where development proposal affecting the facilities will be supported, providing they do not have any significant adverse impact on the community value of the facility. An exception to this is if a similar quality or better facility is provided nearby.

Some of the facilities identified are ancillary facilities related to playing field sites. If the facilities are lost then this could prejudice the use of the playing field site, the supporting text fails to recognise this and even if replacement provision is provided it should accord with NPPF paragraph 99.
